


Figure 2.1: Python example plot 1, a simple sine plot.




Figure 2.2: Python example plot 2, a sine and cosine plot.




Figure 2.3: Python example plot 3, a scatter plot of random data.




Figure 2.4: Python example plot 4, an exponential plot showing how tex can be used within python.

A major point in this chapter should be to demonstrate that you are aware of the research of others. Thereby, you should clearly identify how your approach deviates from theirs. There are many ways to write related works.

The idea to utilize the Holtzmann effect to fold space was conceived 1965 by Herbert [1]. In the following years, he incrementally refined the theory [4–6]. After his early death, Herbert and Anderson [7] continued the research and formalized the Holtzmann theorem, which made space travel significantly more safe (cf. [2, 3, 8–10]).

However, all these approaches to fold space are severely dependent on the resources of the Spacing Guild¹.
